1. Approval of Meeting Minutes:

January 16, 2019. Brian Anderson moved to approve. Dan Larsen seconded. Minutes approved.

2. Financial and Administrative Matters:

- a. Budget Review
 - i. Mark Silow reported that Lexwork Americas income is based on 20 members at \$6,000 annually, plus reimbursements from previous years.
 - ii. Mark said the guess work in preparing the 2019 Budget, is on the expense side: He offered explanation of the following
 - 1. ICC May 2019 Meeting in Milan: budgeted \$7500.
 - Governing Board Annual Meeting Travel Expenses: budgeted \$63,000

 Mark reported that he increased this to bulk up and to take into consideration the new reimbursement policy.

- i. Michael Blachly reported the Lexwork Americas 2018 Referral Report had been distributed via email. Highlights included:
 - 1. All but one firm had reported.
 - 2. The report shows Lexwork Americas firms had generated \$1.5 million in referred matter revenues.
 - 3. This is the 4th highest revenue generated in Lexwork Americas history.
 - 4. In terms of number of referrals, 2018 is the second highest numbers of referrals in Lexwork Americas history.
 - 5. For the last four years, there has been a consistent 190-200 referrals each year.
- ii. Brian Renaud stated he will be emailing a link to an Accountancy Age article which reported that professional networks are accounting for 30% of law firm revenues.
- iii. Daryl Bailey stated he is interested in identifying if is there a way for our firms to create business. Brian Renaud suggested that Daryl start the discussion at the next Governing Board Meeting under the Agenda item "Monthly Intelligence Sharing." Assuming that Daryl's schedule then permits.
